SCOPE OF THIS PRIVACY POLICY

DATA THAT IS COLLECTED AUTOMATICALLY

 - third party payment providers who process payments made over the Website to enable third party payment providers to process user payments and refunds;

in each case, in accordance with this privacy policy.

KEEPING DATA SECURE

- 13. We will use technical and organisational measures to safeguard your Data, for example:

- 14. We are certified to PCI DSS. This family of standards helps us manage your Data and keep it secure.
